

Different Types of Gifts

There are many options you can use to make a gift including cash, stocks, bonds, mutual funds, RRSPs/RIFs, personal property or real estate.

Generally it is preferred if your gift is **undesignated** so that the funds can be used where they are most needed. However if you prefer to designate your gift, in other words, specify how the funds will be used such as land acquisition in a specific region or land management on a specific property or to the endowment, we would be happy to discuss this with you.



Sample Bequest Wording

When remembering The Nature Trust in your will, the correct legal name is The Nature Trust of British Columbia.

Residual Bequest

“I give to The Nature Trust of British Columbia, currently of 260 - 1000 Roosevelt Crescent, North Vancouver, BC V7P 3R4, the residue of my estate (or a percentage of the residue) to be used in such a manner as the Board of Directors of The Nature Trust of British Columbia shall, in its sole discretion, determine.”

Fixed Amount

“I give to The Nature Trust of British Columbia, currently of 260 - 1000 Roosevelt Crescent, North Vancouver, BC V7P 3R4, the sum of \$ _____ to be used in such a manner as the Board of Directors of The Nature Trust of British Columbia shall, in its sole discretion, determine.”

Percentage of Estate

“I give to The Nature Trust of British Columbia, currently of 260 - 1000 Roosevelt Crescent, North Vancouver, BC V7P 3R4, _____ % of my estate to be used in such a manner as the Board of Directors of The Nature Trust of British Columbia shall, in its sole discretion, determine.”
