If you are worried you cannot predict the final value of your estate enough to be comfortable pledging a special gift amount, it is possible to give a percentage of your estate. Even 5% or 10% will do so much.

Tax advantages

Naming The Nature Trust of BC in your Will is a long-term investment in our mission. It will also result in a tax receipt to your estate that can be used to offset 100% of the net income on your final tax return, with excess amounts applied to taxes from the previous year.

There are many options for donating
